IBPS PO Eligibility Criteria For General Candidates

Here is details about the eligibility criteria and percentage for General Candidates who want to appear in IBPS examination.

1. **Age Limit** - Interested General Candidates must be aged in between 20 to 30 years as per 1.01.2016 and there is no age relaxation for General Candidates in this examination.
2. **Education Qualification** - All candidates must have a degree of graduation with eligibility percentage and must be from any recognized university. Candidates are told to attach their report card or score card with their application for the exam (photo copy).
3. **Nationality** - Candidates must be an Indian person with valid identity proof or may be from these countries with proper documents of their citizenship :
 1. Citizen of Indian Nationality.
 2. Citizen of Nepal Nationality.
 3. Citizen of Bhutan Nationality.
 4. A Tibetan refugee.
 5. People who have Migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam who are willing to permanently stay in India and get the citizenship here.

IBPS PO Eligibility Criteria For OBC Candidates

1. **Age Limit** - Same as of General Candidates but an additional age relaxation for OBC (Other Backward Classes) is 3 years. [For Non Creamy Layer]
2. **Education Qualification** - Same as of General Candidates.
3. **Nationality** - Same as of General Candidates.

IBPS PO Eligibility For SC/ST Candidates

1. **Age Limit** - Same as of General Candidates but an additional age relaxation for SC/ST (Scheduled Caste/Tribes) is 5 years.
2. **Education Qualification** - Same as of General Candidates.
3. **Nationality** - Same as of General Candidates.

IBPS PO Exam Eligibility For PWD Candidates

1. **Age Limit** - Same as of General Candidates but an additional age relaxation for PWD (Person with Disabilities) is 10 years.
2. **Education Qualification** - Same as of General Candidates.
3. **Nationality** - Same as of General Candidates.

For Other Reserved Candidates, A

4	Ex-Servicemen, Commissioned Officers including Emergency Commissioned Officers (ECOs)/Short Service Commissioned Officers (SSCOs) who have rendered at least 5 years military service and have been released on completion of assignment (including those whose assignment is due to be completed within the stipulated time) otherwise than by way of dismissal or discharge on account of misconduct or inefficiency or physical disability attributable to military service or invalidment	5 years
5	Persons ordinarily domiciled in the Kashmir Division	5 years
